## 4. SAFETY & HANDLING

### 5. FIRST AID MEASURES

Inhalation: Remove victim from area of exposure - avoid becoming a casualty. Remove

contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical
